## STATUTES - VIII

In exercise of powers conferred by Sec. 22 (7) and (18) read with sections 5(9) and (10), 30(12) and 31, The Syndicate makes the following Statute.

## 1. Title and commencement:

- a) These Statutes may be called the Karnataka Rajya Sampadha Manu Pradarshaka Kalyale Vishwavidyalaya (Acceptance and Management of Requests, Donations and Endowments and Institution of Fellowship, Scholarships, Prizes etc.) Statute - 2018.
- b) They shall come into force from the date on which they receive the assent of the Chancellor.

## 2. Acceptance of Requests, Donations etc., The Syndicate may accept, hold and manage any requests, donations, endowment or funds from any individual or organisations or institutions. However Endowments from the individuals with criminal Background shall not accepted.

Provided that Request, donation, endowment or funds from a foreign country, foreign foundation or any foreign national shall not be accepted by the University, without the approval of the State Government.

Provided further that the University shall accept an endowment for 'establishment of' fellowships, scholarships, prizes, gold medals and other merit awards, which are open to all the students of the University in the concerned course/year at an examination, irrespective of caste, creed, community, religion or region.

## 3. Donation Amount:

The minimum amount to be donated by donors for instituting an endowment in the University shall be as follows:-

**4. Procedure for institution of fellowships etc.:**

- (1) A proposal for the institution of fellowships, endowment, lectures, scholarships, medals and prizes by an individual or body, for any amount not less than the minimum amount mentioned in clause 3, and such cheque or bank draft shall be drawn in favour of the Registrar, Karnataka Rajya Sangraha Mani Pradarshana Kalyaji Vidyapeethyaya Funds. A copy of the terms of award proposed by the donor shall be enclosed with the written proposal.
- (2) No such proposal shall be accepted unless the donor/donors agree the utilization of only 80% of the annual interest/income derived from such bequest or donation for the purpose for which the bequest or donation has been made, and balance 20% of the annual interest/income to the corpus. So as to take care of the escalation of costs due to inflation in carrying out the purposes of the proposal.
- (3) When such a proposal for instituting a scholarship, medal or prize or for institution of posts of professorships, readerships or lectures or other posts of teachers is made, the Academic Council shall be consulted and the proposal along with the opinion of the Academic Council shall be placed before the Syndicate.

(4) The Syndicate shall then consider the proposal and may accept or reject or subject for modifications if required.

(5) If the Syndicate accepts the proposal subject to any such modifications, it shall communicate its decision to the person who has made the proposal for obtaining his consent for the same. Further, even if the proposal is accepted, the said decision shall be communicated to the person who has made the proposal.

**5. Acceptance of donation etc :**

The person who has made the proposal shall then enter into a contract with the University regarding the conditions of the Award as approved by the Syndicate. The Syndicate while entering into such contract, reserve to itself the right to make such further modifications of the proposal as may become necessary for carrying out the purposes of the proposal, unless the donor donates or endows such further fund as may be required.

**6. Investment of amount :**

The syndicate shall invest the amount endowed/donated in Government Securities, as it may deem fit and award scholarships, medals, prizes etc., or institute the 'Chair' or 'endowment lectures' out of 80% of the annual interest accrued. The remaining 20% of the annual interest/income generated shall be added to the corpus of the endowment. If in any year, no medal or prize is awarded such annual interest shall also be added to the corpus of the endowment. Debit accounts for the same will be maintained as per audit norms.

**7. Award of cash prize in certain circumstances :**

(1) If the interest accrued on the endowment amount during any year is not sufficient to award the gold medal, the Syndicate shall have the powers to award a cash prize instead of the gold medal. However if the donor or the candidate who has been awarded the medal offers to meet the entire amount required then the syndicate may consider the award of gold medal itself.

- (2) If the donor desires that the first gold medal or prize should be awarded at a convocation held before the expiry of one year from the date of acceptance of the endowment then the donor may pay the actual cost of such medal or prize separately in cash to the University.

**8. Repayment of amount :**

The amount once deposited under this Statute shall not be refunded under any circumstances.

**9. Award with University Fund :**

The Syndicate can after consultation with the Academic Council and Finance Committee institute fellowships, scholarships, studentship, stipends, medals and prizes with University Funds.

**10. Eligibility for award :**

The candidate shall be eligible for award of Gold Medal/Prize/Scholarship unless the candidate passes the course in the minimum period prescribed and in the first attempt with not less than 80% of marks of the examination as a whole. If the award is for a particular subject / paper the candidate should secure not less than 80% of the marks in the concerned paper / subject.

**11. Donor to be treated as an invitee :**

Every donor shall be treated as an invitee for the University Convocations both special and ordinary. A guest pass will be issued to admit two persons to witness such convocation functions as VIPs.

- (2) Accounts relating to the Endowment Amount shall be audited by the controller S&A once in a year in the month of April.
